THE VILLAGE AT SANTA BARBARA OWNERS ASSOCIATION, INC. RESOLUTION – CROSS REFERENCE 2014 DAVIS STIRLING COMMON INTEREST DEVELOPMENT ACT AMENDED BYLAWS

WHEREAS, the Davis-Stirling Common Interest Development Act relocated from Civil Code Sections 1350-1378 to Civil Code Sections 4000 through the 6000 series as of January 1, 2014, and

WHEREAS, the provisions of the 2014 Act contain language for the most part duplicating the Codes in the Act that existed prior to January 1, 2014, with some Code Sections separated into multiple Code Sections in the new Act, and

WHEREAS, it has been determined that the Amended Bylaws that became effective in 2011 contain references to code sections that have changed because of relocation of the Davis-Stirling Common Interest Development Act,

NOW, THEREFORE, to reflect the references to the new California Code Sections, The Board of Directors has approved, the following action: For the purpose of identifying pertinent changes in the statute numbers, this Resolution with the Conversion Chart for the 2013 statutes to the 2014 statutes relating to those items referring to California Codes, shall be distributed with the Amended Bylaws to any parties. In addition, the Resolution shall be distributed to all current owners for their records.
