WHEREAS, the Restated Declaration recorded in 2011 as Document 2011-0017269 in the Santa Barbara County records contains reference to the relocation of the Davis-Stirling Common Interest Development Act,

NOW, THEREFORE, THIS RESOLUTION IS APPROVED AND SHALL BE RECORDED, AS FOLLOWS:

For the purpose of identifying pertinent changes in the statute numbers, this document with the Conversion Chart for the 2013 statutes to the 2014 statutes relating to those items referring to California Codes identified in the Restated Declaration of Covenants, Conditions, and Restrictions of The Village At Santa Barbara Owners Association, Inc. shall be distributed in the future with any 2011 Restated Declaration of Covenants, Conditions, and Restrictions of The Village At Santa Barbara Owners Association, Inc. delivered to any parties. In addition, once recorded the Resolution shall be distributed to all current owners for their records. This Resolution does not affect or change any of the provisions in the 2011 Restated Declaration of Covenants, Conditions, and Restrictions of The Village At Santa Barbara Owners Association, Inc., nor does it change the effective date (recording date) if or to the extent it applies to any grandfathering in that Restated Declaration.
